The college solar power plant is a renewable energy system comprising solar panels installed on workshop rooftops of capacity 25kW. It harnesses sunlight to generate electricity, providing a sustainable and environmentally friendly energy source for college facilities. This initiative promotes clean energy adoption, reduces carbon emissions, and supports educational efforts on renewable technologies.

Nutan Maharashtra Institute of Engineering & Technology implements a biogas plant, converting organic waste into renewable energy, fostering sustainability and reducing environmental impact.

Institute has replaced incandescent bulbs with energy-efficient LED lights which has significantly reduced lighting energy consumption while maintaining adequate illumination levels. The institute also has energy-efficient appliances such as air conditioners, water coolers and Lift leading to substantial energy savings. Occupancy sensors are allowing for better control and optimization of lighting systems based on occupancy patterns and usage requirements.
