1	The candidates aspiring for admission for Institutional Quota, Seats Remaining Vacant After CAP, it is mandatory to
	get registered, documents verified and confirmation of application at Facilitation Centers (FC).

- These admissions will be made at the institute level by inter se merit from among the candidates appeared in the General Merit List and the list of registered and eligible candidate declared by Competent Authority.
- Admissions for this round will be as per reference rule no.13 of Information Brochure for Admission to Full Time Professional Undergraduate Technical Courses (2023-24) of Government of Maharashtra, State Common Entrance Test Cell as applicable.
- Aspiring Candidates fulfilling the eligibility criteria as notified by the Government and specified by the appropriate authority, from time to time, shall apply to the Principal, for admission at the Institution level as provided in rule 3(4)(b) and shall be filled in on the basis of Inter-Se-Merit prepared by following the procedure specified in 8(3).
- The institution will display the Inter-Se-merit lists of the Candidates to be filled in at the institution level, in the Institutional Quota and the Vacant Seats after CAP, on the notice board and will publish the same on the website of the institution.
- If any CAP seat remains or becomes vacant after the CAP Rounds, then the same shall be filled in by the Candidate from the same Category for which it was earmarked during the CAP. Further if the seats remain vacant then the seats shall be filled on the basis of Inter-Se-Merit of the applicants.
